On comparison of E-Auction and E-Tender bids whichever is highest and subject to the Reserve Price, the intimation of Provisional Acceptance to the E-Auction / E-Tender bidder will be sent ONLY through Emails recorded in the Registration From and NOT by Courier/Post.
- 18. The highest/ successful bidder has to pay the balance Bid Amount alongwith taxes as applicable by way of Demand Draft/ Pay Order ONLY drawn on any Scheduled/ Nationalized Bank Drawn in favour of "Express Industry Council of India" payable at Mumbai. GENERAL

- 45. Employees of EICI / Ashvin & Co. are barred from participating in the Online Auction.
- 46. Any Lot will be put for auction as per convenience of EICI. It is not obligatory for EICI to auction the items as per the serial number.
- 47. Bidder and his men are subject to the security rules and regulations of EICI in force while in the Airport / MIAL premises. The Bidder, workmen, agents or representatives shall not commit any nuisance, theft or indulge in any antisocial activities in the premises and the Bidder shall be liable for the good conduct, safety and discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of EMD.

ARBITRATION

- 52. In the event of any dispute the same shall be referred to a sole arbitrator to be appointed by EICI and the Arbitration proceedings would be governed by Arbitration and Conciliation Act 1996. The jurisdiction for filing the award into court or any other proceedings under the Arbitration Act shall be that of courts in MUMBAI City only. All the expenses pertaining to arbitration shall be borne by the bidder ONLY.
- 53. EICI will not be in any way responsible for failure to deliver the goods as per delivery schedule due to causes beyond their control such as strikes, lockouts, cessation of labour, shortened hours, acts of God or other causes or contingency whatsoever. The bidder/Buyer shall not be entitled to cancel the contract and the period of delivery shall automatically be extended accordingly.
