

**E-auction of presumed Gold, Silver & Diamond / Moti items deposited in the Lost Property Section, Traffic Department, BEST Undertaking.**

- 1.0 **NOTICE IS HEREBY GIVEN THAT**, 70 Nos. of presumed Gold, 104 Nos. of presumed Silver and 10 Nos. of presumably Diamond / Moti unclaimed items deposited by the Lost Property Section, Traffic Department of the BEST Undertaking in the Cash Department, Dadar will be sold through e-auction which is scheduled to be held **on 06.06.2024**. Further, unsold items will be sold through Extended e-auction on the same day between 15.30 hrs. to 16.00 hrs. Accordingly, inspection of presumed Gold / Silver / Diamond / Moti items will be allowed to all those bidders who are interested to participate in e-auction. They can inspect the presumed Gold/ Silver/ Diamond/ Moti items **on 03.06.2024 at 10.00 hrs. sharp** at Conference Hall of Transportation Engineering Department, Dadar Workshop, Mumbai – 400014. Each of the presumed Gold / Silver / Diamond / Moti items will be shown one by one and only once to those who are present during inspection. For late comer participants, the items which are already inspected by other participants, will not be allowed to be inspected under any circumstances, however, they / he are / is eligible to inspect the balance remaining items on sale.
- 2.0 Inspection of abovesaid presumed Gold, Silver and Diamond / Moti items will be allowed on **03.06.2024 sharp at 10.00 hrs. at Conference Hall, 1<sup>st</sup> Floor, Transportation Engineering Department, King'sway Dadar (Workshop) Mumbai – 400 014.**
- 3.0 One or max. two representatives of a bidders will be allowed for inspection.
- 4.0 The intending bidders are allowed to weigh the items, verify the genuineness of presumed Gold/ Silver / Diamond / Moti items by acid test or by rubbing the outer portion of the items.
- 5.0 The intending bidders are required to declare their Gold / Silver / Diamond / Moti belongings while going in for inspection and the Undertaking will have a right to check the intending bidders while going out after inspection of the presumably Gold / Silver / Diamond / Moti items.
- 6.0 After inspection of the presumed Gold / Silver / Diamond / Moti items by the intending bidders, the said items will be kept in a box and sealed by the representative of Cash Department in presence of the intending bidders. Subsequently, signature of all the intending bidders and representatives of the various Departments will be obtained on the seal.
